CONGRESS - EXALT GOD'S WORD - EXPOSE BABYLON

Flee out of the midst of Babylon and deliver every man his soul: be not cut off in her iniquity, for this is the time of the Lord's vengeance; he will render unto her a recompense. [Jer. 51:6]

1983 TRIP TO CONGRESS. Eight of us will go to Washington, D.C. in April to spend two weeks calling on U.S. Representatives and Senators.

We will take to them an expanded index of Bible Law, our 12 page pamphlet on God's Law on Money and we will give them a reprint of a sermon on "America in Bible Prophecy" preached before a joint session of the Houses of Congress in 1857.

In that sermon 125 years ago a Rev. Pitts revealed to the Congress that the United States was the 5th Kingdom of Daniel and that the last great battle to be fought upon the earth would take place when a group of nations under Russia attacked the United States. **He said that America was "restored Israel."** It is startling reading, as you can imagine. Later we will add that reprinted sermon to our literature list.

Our mission to Congress has three main messages. 1. We are the Israel People and the United States therefore is a nation of regathered Israel. 2. Since we are Israelites, our leaders are bound by God's commands to institute God's Laws as the Laws of the nation. 3. Because we have not done this in the past, we, as a nation, are under the judgments of God.

We will also give them our copy of their own resolution, Public Law 97-280, which declared 1983 to be "The Year of the Bible" and in which the Congress itself admitted our "national need to study and apply the teachings of the Holy Scripture." We can use their own words to inform them they should "study and apply the teachings of the Holy Scripture."

Their own resolution has given us a mighty tool to use in the Congressional offices in 1983.

WILL YOU WRITE YOUR CONGRESSMAN?

Write him a short letter asking him to grant us an interview sometime from April 19th through April 28th. Send me a copy of your letter now and his reply later. **I will take your letter with me to show in his office.** Letters from their constituents will often get us an appointment where we otherwise might not have gotten it. Pray for us, and for them, as we go on this vital mission.

I will not be able to attend as I will be leaving for Washington, D.C. at that time.

We will try to help in this way: Write and tell me about men who may be qualified to be I.D. ministers or who are ministers with no congregation. Perhaps in time we can recommend qualified men to Identity Christian groups.

COME TO OUR JULY CHRISTIAN IDENTITY FAMILY RETREAT in New Mexico. We start on July 2nd, end at noon on July 8th.

If you did not receive our information sheet and reservation coupon, write and ask for it. We will have 20 or more ministers and teachers with 4 to 6 class periods each day plus evening worship services.

WANT TO DO SOMETHING FOR AMERICA?

We sent Ty Hardin's columns to our whole mail list, asking them to go to local weekly papers to see if they would carry them. **We heard back from less than 10 people who had actually taken the time to try to get Hardin's columns in a paper!** Not a very good number considering that thousands write us over a period of

weeks to state their "concern for America!" Are they "Concerned" only if it doesn't cost them money or take any time?

LETTERS TO THE EDITOR: The most economical method of reaching your neighbors with bits of truth is through letters to the editor of your local newspaper.

You can complain to others verbally, you can even write long letters to other Patriots, and very few will know what you are saying. However, write down those same words and send it to the editor and not only will he print thousands of copies, he will distribute them for you!

If you cannot write at all, copy a thought out of a Patriotic article, sign your name to it and send it in to the paper.

Many are already doing this. Newspapers all over the country are now printing letters to the editor on subjects they were afraid to cover before. Try it!

FORECLOSURES ARE REACHING THE RATES OF THE 1930'S. Farmers are being especially hard hit with both Banks and the FHmA refusing to renew their loans, taking them into foreclosure instead. Many on our mail list are ordering our money cartoon packet, having one or more of the cartoons reprinted locally and passing them out at farm auctions. We'll send you a packet if you write and ask for it.

Others have run our ad from SPOTLIGHT in their local newspapers. Thousands of our Billion\$ for the Banker\$ are being distributed that way.

SOME ARE LEARNING OF THE POWER OF THE SHERIFF: Sheriff James A. Traficant of Mahoning County in Ohio was reported in the Youngstown paper to have refused to sign the foreclosure papers on houses where the owner had been forced to move. He said people were losing too many houses. Judge Charles Bannon charged him with "contempt of court" and sentenced him to 100 days in jail! The judge was in the wrong, but our people know so little of the common law they do not realize that a sheriff has the power to do such things.

The quickest way I know for you to learn and teach your neighbors how the people as a whole can protect themselves from tyrannical government is to get the 58 minute TV cassette from Red Beckman on your 3 votes: elections, the grand jury, and the jury. Most Americans do not know that if they get on a grand jury they can indict anyone for criminal acts. In 1982 a grand jury in Utah indicted the Federal Reserve Board for criminal acts.

The State Attorney General is trying to quash the indictment, but he really has no legal power to do so. **The grand jury, made up of citizens just like you, has more power than the Attorney General.**

A WARNING OF SMEARS: A professing Identity group on the Missouri-Arkansas border calling itself

The Covenant, Sword and Arm of the Lord (CSA) has been very radical in its statements, has openly boasted of its weapons, food storage, etc. The news media gave them much coverage, shot a lot of TV footage of them, then ran a television special in St. Louis about them, painting them as "dangerous," "killers," "right-wing radicals," etc. Large ads promoting the TV program were run in the St. Louis and other Missouri papers. At the same time left-wing legislators introduced a bill in Missouri to "ban" paramilitary training and provide penalties for anyone who instructs others in the use of weapons or explosives with the knowledge such weapons or explosives might be used in creating disorder, etc., etc.

This is a classic example of "forced legislation!" The CFR news media startles and frightens the citizens and the lawmakers with massive publicity about some phony danger. Then a left-winger in the law-making body comes forth with "the solution," a "new law to take care of this grave danger to our society." Most legislators, not understanding how they have been manipulated, vote for the law. It may be years before some of those legislators realize they voted for a law which will be used to harass and possibly imprison Patriotic Americans while the **left-wing terrorists, including the JDL**, go right on with their disruption of our nation.

By this method those who control the news media actually run our country, causing laws to be passed and enforced, not with logical arguments to the people or to the Legislature, but with smears and sensation on TV and in the Press! We are literally a nation run and controlled by those who own and control the news media.

USE THE RIGHT WORDS: As above, don't just say, "News media," say, "CFR news media." With all the publicity on the CFR going around the country, many will know what you mean and be reminded it is not the people's news media, the news media belongs to the CFR.

Remember the others I told you about. Add "minority" whenever you use White Race or Christians. Don't say, "The White Race," say, "The minority White Race." And always call the Bible the "Christian Bible."

DON'T BLAME ME FOR THE BAD NEWS. I do get some mail criticizing me for putting anything other than "Bible teaching" in my newsletters. They say some of the other Identity ministers print up only studies on the Kingdom, Christian living, etc., and leave all that "bad news" to the "devil," and Emry should do the same.

Well, if my newsletter were the only "preaching" I did, the criticism might be valid. However, I do a 30-minute radio broadcast every week and a church sermon most weeks in which I use the Bible to explain both the good news of the kingdom and some of the bad news of this present world. It is not as if I were not teaching the Bible at all.

In addition, my newsletter is a way of passing on

some of the month by month doings and happenings in the real world in which we live. Sometimes, as some of the articles above, it is a word of wisdom and a word of warning about the wolves who live among us, not all of whom are in the forest or in church pulpits.

A LITTLE EDUCATION ON MONEY: Scores of so-called experts are writing financial newsletters and speaking publicly about our money system. Some even get the ears of the Christian Patriots by seeming to be against the Federal Reserve System, but teach falsehoods which deceive the Patriots who need to know

the truth.

Here is a short lesson on how to use common sense to spot the phonies.

A common teaching by some "money-experts" goes like this: "the government was printing money hand over fist" (William Simon in Time for Truth), or "Inflation is caused by the government's continual creation of new money" (Murray Rothbard in Ron Paul's book, Gold, Peace and Prosperity), or as Ron Paul says in the same book, "Congress and the Federal Reserve have generated a flood of paper money..." Paul puts out a monthly newsletter as does F. Tupper Saussy, Gary North and scores of others which repeat and repeat, "The government is printing too much paper money." These men will say, "No wonder the government spends so much, all they have to do is crank up the printing presses." Such statements, **if not examined with intelligence**, are accepted as fact by most Patriots.

Let me answer those claims with the common sense of Abe Austin, an Illinois hardware dealer who knows more about money, or at least has more common sense, than most of the followers of Paul, North, Saussy, et al:

"Anyone with a normal I.Q. can quickly perceive that there is something wrong with such jargon, because it does not jibe with fact. If the government does create and print money, what does it do with it? **If the U.S. Government prints money to pay its obligations - why is the Government getting into greater National Debt?**"

Abe gives the only answer possible, 'If our Government did print Treasury money to finance its obligations as indoctrinated pundits and the deluded money reformers are claiming - the U.S. Government would have no national debt.' I say, "Amen."

Now, after reading that, will you all try to use the common sense God gave you to **examine every claim made by professing "money experts"**? I am beginning to believe that, like in George Orwell's 1984, America's Patriots are being deliberately provided false and lying "leaders" to neutralize them in regard to money. As Abe Austin knows, and Peter Cook knows, and Robert Record knows, and Sheldon Emry knows, America is not suffering from "too much money," America is instead suffering from a "shortage of money." That "shortage" is deliberate and is designed to **force us to borrow Banker's credit and use it as money!** By throwing up the smokescreen of "too much money in circulation," the scores of Judas-goats of Money prevent the Patriots from realizing the true solution to America's money problem is the one Abraham Lincoln used over 100 years ago, and no President has used since, **print interest free and debt free paper money!**

How many of you have even gotten suspicious about the sudden appearance of hundreds of "financial newsletters" in the last 5 years? Especially since every one of them, no matter what other disagreements they might have, all speak with one voice on money, "We must have gold-backed money, paper money is terrible," and on and on and on. And all support Ron Paul's "gold bill" and Gonzalez' bill to transfer the functions

of the Federal Reserve to the U.S. Treasury. That is prated as a solution but they don't tell you that would simply make our whole system match that of Britain, Canada, France and Germany where the "money-changers" sit in the National Treasury, not even in a separate corporation as does our Federal Reserve. That is exactly what they want, to become an integral part of our government and eliminate any possibility of our just "repealing the Federal Reserve Act" and getting rid of them!

GOVERNMENT AGENTS QUESTIONING CHRISTIAN PATRIOTS: FBI agents, Secret Service agents, and people from other departments of the Federal government are coming to the homes or places of business of Christian Patriots and questioning them about their personal lives, business, business associations, and many are being questioned about other people who are active in Christian Patriotic organizations.

These government agencies are now compiling information on who is who in the Christian Patriot movement.

YOU DO NOT HAVE TO TALK TO THEM! Most Americans, including many who are knowledgeable about their rights, assume that if a government employee (that's what an FBI agent is) comes to you and asks you questions you have to answer. Not only do you not have to answer, if he comes on your property, you are within your rights to ask him to leave. If he refuses, tell him you are calling the police and do it. They are as liable for trespassing charges as is any person who refuses to leave private property when ordered to do so.

My personal opinion is that Christian Patriots should not cooperate in any way with the FBI, the Secret Service or like organizations. The U.S. Government quit persecuting and prosecuting communists over 20 years ago. The U.S. Federal Government is now effectively under the control of pro-communists who are using the FBI and the Secret Service to wage war on Christian Patriots. We delude ourselves if we continue to think the U.S. Government, which sells and gives the Communist nations our food, our technology and our weapons and helps the Reds every way it can, would continue to allow any of its internal arms to be anti-communist!

Whittaker Chambers, who was in the communist party during the 1920's and 1930's, and was the man who "fingered" Alger Hiss, wrote a book, "The Witness," in the 1950's. In his book he said of his experience in the U.S. Department of Agriculture in 1934, "**Every new employee hired into the department under Roosevelt was ideologically a communist!**"

That was 49 years ago! It is probable that the FBI and the Secret Service are as riddled with outright communists as is any other branch of the Federal Government. Don't be foolish and help them in any way to do their dirty work against Christianity and American Patriots.
