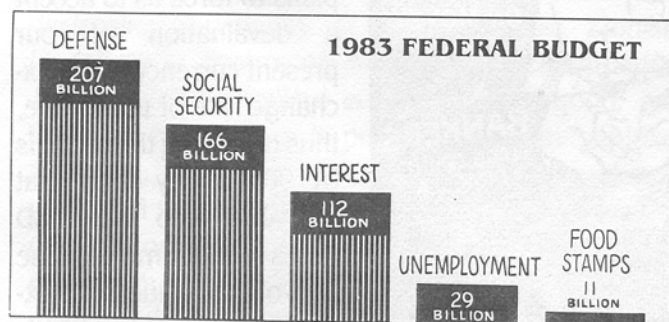

DOLLARS AND SENSE

BALANCED BUDGET FARCE: Recently, government bureaucrats threatened U.S. citizens, telling them that government functions would be "shut down" if Congress did not approve a higher ceiling for the national debt, allowing them to borrow more credit from the Bankers and enlarge the deficit debt. Eventually, Congress ok'd the debt expansion, and our nation now finds itself over \$2 trillion in the red, and the debt is growing exponentially. In fifteen years, if things continue as they are, the debt will reach \$13 trillion.

How much is \$2 trillion? If you had \$2 trillion cash, in \$100 dollar bills, how long would it take you to count them? If you were able to count one bill per second, 12 hours a day, seven days a week - you would be done in just 1,268 years.

However, if you tried to payoff the \$2 trillion national debt at that rate (\$100 per second, 12 hours per day, 7 days a week = \$1 1/2 billion dollars per year), you couldn't even keep up with the interest. Indeed, even if you counted \$1,000 bills at the same rate, you still couldn't begin to catch up with the interest on the debt. The interest alone, in 1983, was \$112 billion. It is considerably more today. Therefore, it would never be paid-off even if no more was borrowed. That gives you some idea of how much \$2 trillion is.



The Federal Reserve System makes national indebtedness unavoidable. The only way to avoid debt is to avoid money since money can come into existence only through debt. Therefore, as long as we retain the present Federal Reserve System, there is no hope of ever paying the debt. Thus, the FED, the Congress that authorized it in 1913, and each succeeding Congress that has refused to abolish it are all guilty of directing America's economy down the road to ruin for the past 73 years. The debt can do nothing but escalate at an ever-increasing rate.

The Reagan administration, in keeping with its "Promise Them Anything" policies, has been promising "tax reform" and "a balanced budget." Millions of people watch President Reagan with adoration as he says good-sounding things on television. The rest of us sit back and wonder why he promises things that he knows he cannot deliver. Does he understand what he is saying?

In spite of current rhetoric and political nonsense, balancing the federal budget under the present banking system would only increase America's economic problems. Why? Because it would cause the public money supply (also known as M-1) to be drastically reduced much the same way it was reduced in 1929. The result would be the same as it was then: instant depression!

Most of you remember what happened when the Bankers called in their loans in 1929. Wall Street closed up, and people began to panic. Why? Because when the banks pulled in their loans, it caused billions of dollars to fall out of circulation: out of the public money supply. That, then, left the public without enough currency in circulation to facilitate trade and

commerce. America was stifled economically; not because we couldn't produce, not because we weren't willing to work, but because there wasn't enough currency (the life blood of a society) in circulation.

In 1929, the called-in loans were mostly from the private sector. Today, with this balanced budget proposal, the called-in loans would be, initially, in the public sector (government bureaus). The 1986 federal budget deficit will be over \$200 billion. To balance that budget would extract \$200 billion out of the public money supply (M-1) right away. This would have an effect reaching into the private sector and causing even more loans to be withdrawn, thus reducing the public money supply (M-1) even further.

The effect that the M-1 money supply has upon our nation can be compared to a man's circulatory system. For the body to function properly, his blood supply must be maintained at just the right amount; neither too much, nor too little. Reduce the blood supply too much and the blood pressure can drop so low that the patient may die.

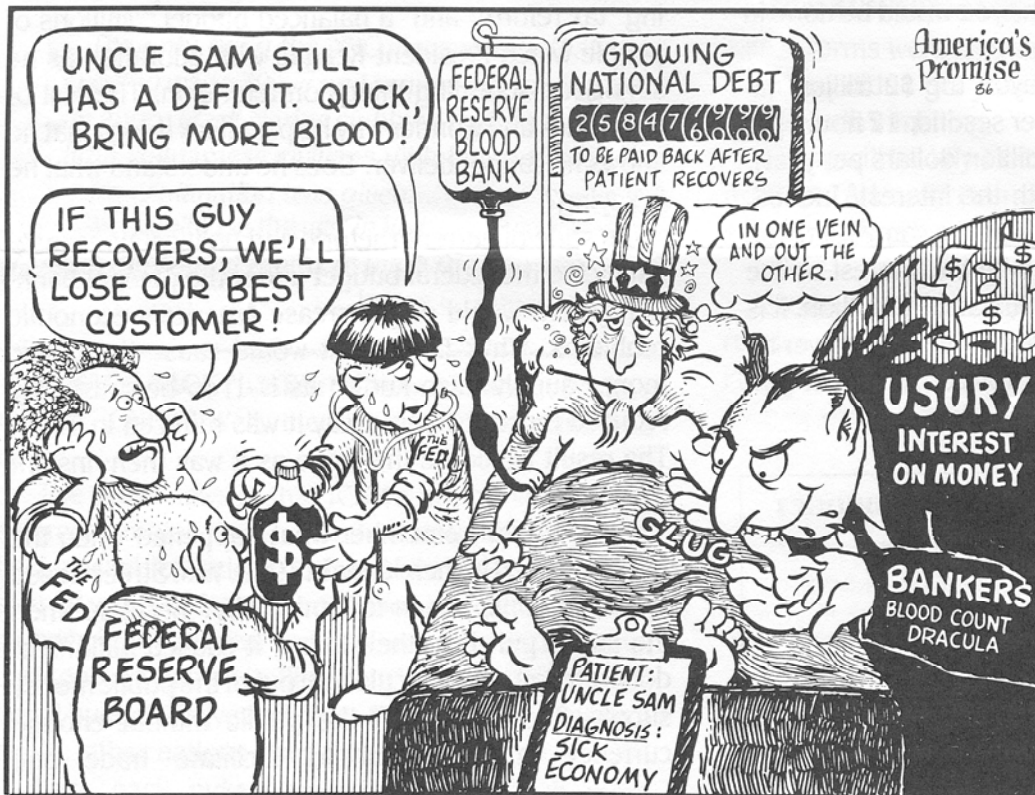
American economy is sick. The problem? It is leaking money, just like a person with a ruptured artery leaks blood. However, in Uncle Sam's case the leak has been engineered by malicious people. The usury-bankers have designed and caused the leak, just like a vampire causes a leak in his victim's artery. The result, in either case, is that the patient gets sick.

Could you maintain faith in a medical team whose only remedy for a ruptured artery is to simply keep replacing the lost blood with more and more transfusions? When an artery is ruptured, the most urgent thing is to stop the bleeding and bandage the wound. A doctor who ignores the wound, the actual cause of the patient's low blood supply, is not worth much.

By the same token, how can we have faith in economists and politicians whose only remedy for America's ruptured economy is to simply keep replacing the lost currency with more and more usury bank loans, thus trying to keep enough currency in circulation? Why don't they plug-up the money leak? Why don't they treat the cause instead of the symptom? Are politicians trying to cure the patient, or are they simply keeping the patient alive so he can be a permanent host to thousands of parasitic bureaucrats and bankers?

Under present conditions we can forget balancing the federal budget and paying off the national debt. It cannot be done until the whole Babylonian money system is thrown off. We must first plug-up the usury leak, and then begin afresh with God's laws. As long as the only way to get money into circulation is through banks loaning us credit at interest, there is no possible way to balance the budget without pulling too much currency out of circulation. Neither can we pay the national debt because there is not enough money, nor credit in America to do so.

BLOOD MONEY



NEW MONEY: The Federal Reserve will probably put into circulation a new issue of currency soon. It may have some subtle changes in tint and/or markings.

Now, a rumor is being spread across America that the new issue will cause a "devaluation" of our old currency. Those who advocate this warn that the FED plans to force us to accept a devaluation of our present currency at the exchange rate of ten to one, thus devaluing the old bills by 90%. They warn that everyone who has FED Notes at that time will lose 90% of their value in the exchange.

Such a devaluation is IMPOSSIBLE. This rumor has caused needless worry, and even panic in many cases. It makes a good story in "economic newsletters." People have been advised to exchange their paper money for coins, which they claim will not be devalued along with the paper money. Others have been advised to buy gold and silver as a hedge. What these economists fail to tell their readers is that America's currency is NOT inflated. In fact, it is deflated! For the last year or so, the paper dollar has gained in power against both gold and silver.

I first became aware of these warnings over two years ago when I received some writings from Congressman Ron Paul. He advised everyone to buy gold because "paper money was not dependable." Oddly enough, aside from his newsletter business it just so happens that he sells gold and silver too.

Several months later, during his appearance in Phoenix for the opening of a new gold and silver brokerage, Mr. Paul admitted to me that he didn't believe that the devaluation would happen. However, apparently his friends and followers didn't get the message. Gold and silver continued to be held up as the saviours of America, and everyone was advised to buy, buy, buy. Since that time, gold and silver have plummeted in price.

The truth is too simple. Neither gold, silver, nor U.S. coins will protect us from being enslaved by usury. Our only protection is God's law. Usury is theft, and God forbids it.

Is there any truth in the devaluation scare? I don't think it is possible for a devaluation of that description to take place. As far as I know, there are two ways to devalue currency:

1. Devaluation by overthrowing the government.
2. Devaluation by inflation.

Will our currency be devalued? Not unless our government is overthrown, or the FED puts too many bills in circulation, causing an inflation. A forced exchange of ten dollars for one would be nothing short of confiscation: an outright act of war. It could never be accomplished short of military intervention. Not even an idiot would stand idly by while the FED confiscated nine-tenths of his cash, property and personal assets in one fell swoop. I don't think the FED wants a civil war on its hands.

I know of no example in history of a currency, or a commodity ever being devalued against itself. I have

heard of confiscation of lands and properties through military conquest, but that is not the same thing that Ron Paul and others have been forecasting. A currency can appreciate, or depreciate against foreign currencies, and against other commodities, but never against itself. When the newspapers tell of the devaluation of the Israeli shekel, or the Mexican peso, that means they have been devalued against the U.S. dollar; not against themselves.

Even if a "new dollar" was issued at ten times the value of the old dollar, values would remain the same. The new dollar would simply circulate at par with ten of the old. There would be no "devaluation," only an "exchange:" old currency for new. New contracts would specify whether the amount is designated in "new currency" or "old currency," and old contracts would maintain their "old currency" value. When paying an old debt with new currency, you'd just knock one of the zeros off the old figure. As the old currency would go through the banks, it would be destroyed and replaced with the new issue.

The effect would be not much different than if we stopped minting pennies and nickels. It would reduce the number of coins a business would have to keep in the cash register. Any pennies and nickels still in circulation would not be worth less than before. They would be redeemable in dimes at the standard rate until they were all taken out of circulation.

Germany's inflation of 1919 to 1923 is a classic example of true inflation of currency. The public supply of currency went from 50 billion Marks in 1919, to nearly 500,000,000,000 billion in 1923: 50 billion times greater than just four years earlier. Nothing like this has ever happened in America, and certainly not at the present time. As I stated earlier, America's currency is not being inflated. It's deflated. There is a shortage of currency in America today. In fact, we're getting dangerously close to a depression: the opposite of what happened in Germany.

It's not too difficult to surmise that Germany's inflation wasn't just an accident, nor was it due only to internal mismanagement. There was an international conspiracy to pump currency into the German economy, inflating the money supply and destroying confidence in the government. The Reichsmark was issued in 1924, exchangeable with the old Mark at one-trillion-to-one. However, the exchange itself didn't devalue the old currency. It was simply an admission that the old currency had already been devalued by mismanagement and the inflation conspiracy.

The exchange was necessary. The German people

were unable to carry enough cash to do business. They needed a wheelbarrow of cash to buy a loaf of bread. Using the new Reichsmark also eliminated twelve zeros on the face of the bills. The new bills were simply more valuable than the old. But remember, devaluation of the old bills was due to inflation. It wasn't caused by the exchange of the new issue.

A similar thing happened again in Germany, in 1948, when the Reichsmark was replaced with the Deutsche Mark, at the exchange rate of ten to one. Hitler's Germany had been defeated, and the currency of the Reich no longer enjoyed the confidence of the public. The new German government, under control of the United Nations, had to issue its own currency. Again, the new currency did not cause the old to be devalued. The old was already devalued by military conquest.

In both cases, in Germany, the difference in value was the currency of an old regime against the currency of a new regime. The exchange rates merely INDICATED the devaluation; they didn't CAUSE the devaluation. The devaluation had already happened. A national currency is never devalued against itself!

Patriots and Christians are being exploited by merchandisers, and excited by rumor mongers who cry "wolf" for no other purpose than to get attention. Others are simply parroting misinformation.

DIVERSIONS NEUTRALIZE PATRIOTS: Is it possible that this whole devaluation rumor is nothing but a straw-man diversion, devised to keep your attention while something else is taking place? What are the bankers really doing? Do they need more money from us? Don't they have mortgages on the whole nation as it is? What, then, do they want?

They don't want money. They want CONTROL! Big Brother hates cash because it allows for private transactions. Unmarked cash insulates you from him. Therefore, he doesn't want you to have cash, and thus the ability to maintain your privacy. The FED and the IRS have even brainwashed you into feeling guilty about wanting privacy.

They would like to prevent you from dealing in cash altogether. They want you to either write checks, or use credit and debit cards. That way, every transaction goes directly into their computers, and they know everything about your life. They know how to tax you, how to control you, and if necessary - how to destroy you!

No, the danger is not a so-called devaluation, but rather a trend toward a cashless society where all trans-

actions are recorded in computers and everyone is given a computer card with his own personal number. This, then, will destroy individual privacy. Everyone in that system will be unable to buy or sell unless they get approval from the computers, and from those who control the computers. Where there is no privacy, there is no freedom!

I suspect that any new changes in our bills will lean toward making them less susceptible to counterfeiting and more capable of being traced as they travel through society, thus putting us one step closer to a cashless society. They may incorporate a metallic magnetic strip in them for the purpose of quick computer identification and inventory. They may not be as good as credit cards for their purposes of control, but they will be easier to follow than the current unmarked bills.

NEW CHILD ABUSE COURSES: The following is quoted out of the September 1985 Parents Advisory Center News:

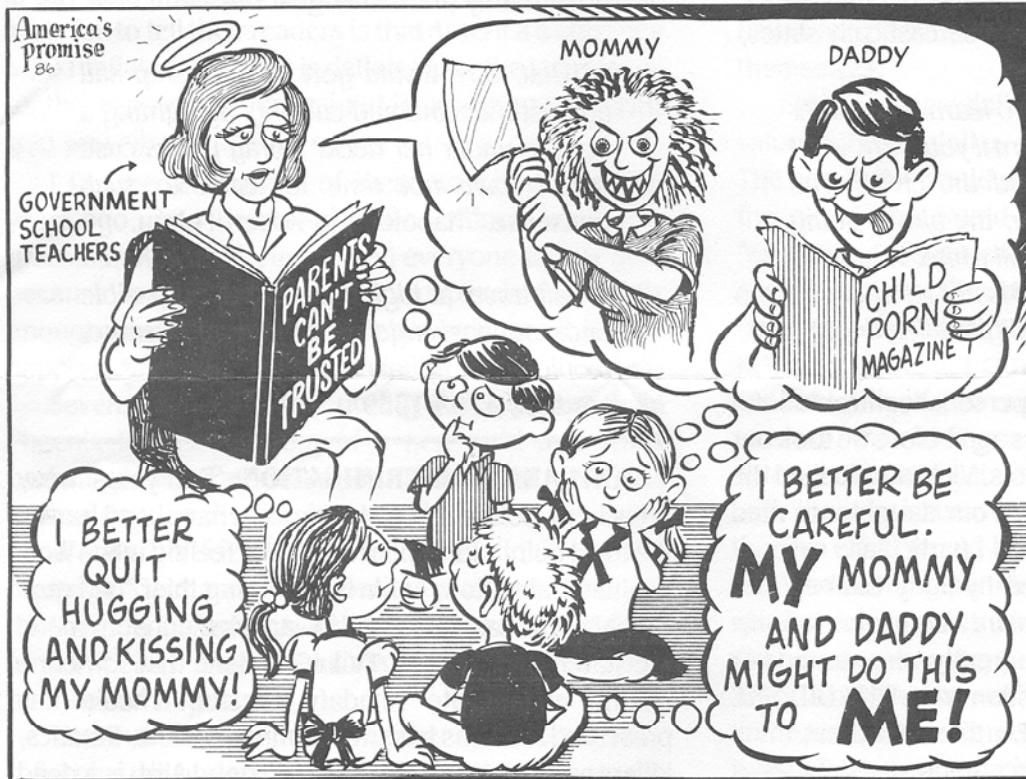
"Children are being submitted in growing numbers to Child Abuse (Incest) curricula in the classrooms. Many of these courses scare the child into believing that the home is a hostile environment and that the chief threat to his safety is from someone in his own family. One program called "Protective Behaviors Anti-Victim Training" is claimed to be in 34 states. It consists of lessons about horrible hypothetical experiences that allegedly may occur to a child in his home or as a result of the misbehavior of his parents. The child is required to set up a network of NONparents in whom he is to confide. The manual never mentions mother, father, mom or dad, but refers exclusively to "grown-ups at home" or "household people."

Another elementary school course is "Bubylonian Encounter." It's a play with classroom discussion about a creature named Bub, who arrives from Bubbylonia to teach about "good touching and bad touching." The course compels classroom discussion of incest and forced sexual touching at the third grade level. The NEA has developed a Child Abuse and Neglect Training Program for use in the schools. Like the others, it is anti-parent. One section "focuses on the

problem of the patriarchal father, dominating the home with absolute authority and free to view his children as his own possessions."

CHILD ABUSE CLASS



Classrooms are also being invaded with "Stress Activities." Imagine a class of first-graders being required to lie down on the floor of the classroom to eliminate "stress," or a first-grader telling his mother that he has "a person living inside him" and "no one else is to know; it's a secret." These exercises are part of a strange new course inflicted on children usually called "Q.R." (Quieting Reflex).

Q.R. is experimental psychological treatment which variously, (1) takes children on a guided-imagery "trip" into a fantasy world, (2) subjects them to the early states of self-hypnotism, or (3) takes them into transcendental meditation, Eastern mysticism, yoga, suggestology, or the occult. Children are told that stress occurs "when parents get into the picture."

In Q.R., children are told to go for advice to the "wise man" living inside their bodies (instead of to their parents or God). Children are told to "Breathe slowly through the im-

has been declared void "for vagueness," and Ohio's law is being challenged for vagueness.

Most of these states require parents to get permission to teach at home, either from the state, or the local county school superintendent. Often, parents are required to pass proficiency exams, and/or report test results annually. However, more and more parents are refusing to contact "the authorities" choosing to just remain anonymous. They want the State to admit it is a constitutional right, and that they don't need state permission for it.

One parent in Florida who refuses to comply with the testing and notification says he views it as government interference.

"I think it's parents' God-given right to educate children as they see fit and it's none of the government's business," he says.

His four children attended private school until he and his wife started teaching them at home. Their names don't appear on any public school lists.

HOME SCHOOLS:

Eight states adopted legislation in 1985 making home education legal. That brings the total number of states with similar laws to 19, and the number is growing. Home education was legalized in Nevada in 1956, Utah in 1962, Louisiana in 1974, Ohio in 1976, Missouri in 1977, Vermont in 1982, Wisconsin, West Virginia, and Arizona in 1983, and Georgia and Virginia in 1984. In 1985, Florida, Arkansas, Oregon, New Mexico, Wyoming, Rhode Island, Washington, and Tennessee followed suit. However, Missouri's law

"The county superintendent doesn't know I exist now and I'm not going to report to them . . . I want to remain anonymous," he said.

Statements by Joseph Orr, Associate Superintendent of Instruction in Palm Beach County, Florida, published in The Miami Herald, September 29, 1985, reveal the real problem. He sarcastically states,

Our question was, WHY DID SHE HAVE TO LEARN IT AT ALL? Do these teachers think pornography and smut is acceptable as long as it comes from the schools?

Government School Officials, and the N.E.A., don't think that your young child should be shielded from heathen religions, drug abuse, peer immorality, and anti-Christian teachers. They don't think parents have the right to raise their own children to follow in their parents ways. The government schools are destroying families by the millions! They're destroying the American way of life! If you love your family; if you love your American heritage, you'd better get your children out of the international corporate government schools!

Today's generation of children will be America's leaders tomorrow. All the N.E.A. needs is one whole generation processed through their schools, then they will have taken control via the children. If we don't save some of our children as leaders of the next generation, America is lost.

ANTI-ARAB DISCRIMINATION: For years now, preachers, politicians and the media have used Iran as the focal point with which to cause ill feeling in the West against Arabs. Now, Lybia is becoming their "bad guy" in the Middle East. Senator Howard Metzenbaum made the statement on WKYC-TV in Cleveland that someone should assassinate Khadafy. Western media has presented Arabs as backward, unreasonable, fanatics, killers and war mongers: "the only good Arab is a dead one."

First, it was the Ayatollah Khomeini of Iran. Now, it is Moammar Khadafy of Libya. Western preachers, politicians and media are doing the same thing to the Arabs in general as is being done to the Israel Identity movement in America. They are publicly assassinating their character.

But why pick on the Arabs? Is Arab misbehavior the only kind worth noting in the world? What makes Arab criminals so much more newsworthy than Eskimo criminals? Why is Arab crime worse than Israeli crime; or American crime for that matter? A resolution passed by the 45 member Islamic Conference Organization condemns 'aggressive escalation on the part of international imperialism and the Zionist entity' against Col. Moammar Khadafy's radical Arab government.

In its resolution, the Islamic Conference pledged "firm solidarity with the Arab Libyan people and its active support in the defense of their sovereignty, territorial integrity and territorial waters."

It "calls the attention of the international community to the constant provocations and aggressive escalation on the part of the international imperialism and the Zionist entity against the Jamahiriyah (Libya), and the ensuing serious results for international peace and security."

Why is America being brought against the Arabs? I believe the bottom line is this: the Arab world is the only remaining part of the earth that is not under total control of the international bankers. The Arabs, because of their wealth from the oil industry, and also because of their strong will to remain independent, have not been sucked into the same banking vortex as the rest of the world (at least not yet). Therefore, the Israelis are, in effect, agents of international banking powers with one major objective in this day and time: cause western society to hate and destroy the Arabs.

International Judaism was created as a tool in the hands of the One-Worlders. In America, Judaism is destroying Christianity. In the Middle-East, Zionism (Judaism) is destroying the Moslems. DOUBLE STANDARD: Two men were recently murdered by terrorists. Both were Americans. Leon Klinghoffer, an elderly, wheelchair-bound Jew, was allegedly murdered by Palestinians on an Italian cruise ship. Alex Odeh, West Coast regional director of the American-Arab Anti-Discrimination Committee, 41-year-old college instructor, family man with three daughters, aged 7, 5, and 2, was murdered when a bomb, rigged with a trip-wire, exploded as he entered his office in Santa Ana, California. A member of the Jewish Defense League phoned claiming responsibility for the bombing.

Two men cruelly murdered: one a Jew murdered by Arabs; the other an Arab murdered by Jews. Both occurred within a few days of each other. Did these two victims receive equal attention from our government and the media? Hardly!

President Reagan "called out the troops," sending Air Force fighter jets to apprehend the get-away plane carrying Klinghoffer's alleged murderers. Leon Klinghoffer's name was in the headlines of every newspaper, and on the lips of every TV news reporter for over a week. The First Family entertained Klinghoffer's widow, and she was honored in various ways by State Department, media, and public. There was even talk of awarding Leon Klinghoffer, posthumously, with the Congressional Medal of Honor. What of Alex Odeh? Well, it was too bad, but no big deal. His murderers are not captured. The Jewish Defense League is not reprimanded. News media has explained that he was just a "random victim." Irv Rubin, leader of the JDL, said "I have no tears for Mr. Odeh. He got exactly what he deserves."

MEDIA BIAS: The following is from a letter to the editor of the Washington Inquirer, August 2, 1985.

While viewing the program "Television's Vietnam, The Real Story," I recalled an episode that happened in the late 1960's while I was assigned as a cameraman on the NBC Huntley-Brinkley evening news report.

One afternoon, while I was in the videotape room, I watched in awe as a 2-3 minute segment of raw, unedited footage was viewed. It showed a Marine squad walking through a Vietnamese village. The Marines were cautiously checking each hut while calling to the villagers to come out, which they did.

All at once, hell broke loose when a man and a woman appeared with their arms folded across their chests. As a Marine stopped them, they suddenly raised their arms, and grenades fell to the ground and exploded, killing the Vietnamese as well as some Marines. Immediately, other Vietnamese attacked the few disorganized Marines left uninjured.

At this point, a black Marine sergeant picked up a carbine and, using it as a club, he fought off the Vietnamese to keep them away from his dying and mortally wounded comrades.

The only thing the NBC viewers saw that evening was a 30-second sequence showing an angry black Marine clubbing the heads of little Vietnamese civilians with his carbine!

No explanation was given.

We didn't lose the war in Vietnam - we lost it in the editing rooms of the 3 TV networks.
