GENOCIDE TREATY

I knew it was just a matter of time before they played their trump card. After holding it in reserve, and debating over it for 36 years, they've decided that now is the time. They needed a strong measure to help them put down the growing patriotic Christian movement in America. However, the thing that they will not learn until it is too late for them is that open attempts to suppress American Christians usually have just the opposite affect: they cause us to rally.

The Internationalists played their trump card Wednesday, February 19, 1986. The vaunted Genocide Treaty was finally adopted in the Senate by a vote of 83-11. They added some "provisos" before ratifying it, declaring that the U.S. would retain sovereignty in actions taken upon American citizens under the treaty, however, the provisions are empty and meaningless in real law.

Patriot Christians are strongly national in ideology. They believe in national sovereignty for America which requires that treaties and alliances with other nations be avoided. By definition, an international treaty automatically supersedes any national constitution or law. Therefore, this newly-adopted Genocide Treaty with 96 other nations has become a higher law in America than our Constitution.

The possible ramifications of this treaty are scary. In West Germany, Canada, and other nations which have adopted a form of this treaty, charges are being brought against people who "preach hate" or "hurt the feelings" of a religious or ethnic group. As far as the American pulpit is concerned, the Genocide Treaty will fasten the lid on the coffin of the First Amendment. The Genocide Treaty is a public declaration that the religion of the United States of America is "International Pluralism."

Of course, the major area in which the Genocide

Treaty has been brought to bear in both Germany and Canada is with reference to denials of the Jewish-declared "Holocaust" of six million Jews in Nazi Germany. Men who have taught and/or published material challenging the accuracy of the Jewish claims have been prosecuted for "spreading hate." We have yet to see what government actions this will cause, and what effects it will have among American Patriot Christians.

FORMER NAZI EXTRADITED FROM CALIFORNIA:

Andrija Artukovic is 86 years old, blind, senile, has heart disease, and other ailments. A few days ago, he was taken into custody, spirited away from his home and family, and flown to Yugoslavia to face charges that he ordered the deaths of Jews during World War II. This was not done under the Genocide Treaty, but it shows the mentality of the One-Worlders who are behind the Genocide Treaty.

In light of Reagan's recent stand defying the World Court, in the case of the lawsuit filed against the U.S. for supporting and directing anti-Sandinista forces in Nicaragua, it is obvious that Reagan can defend us against International Tribunals if he so desires. In America's Promise November-December 1985 newsletter, I reported on Reagan's refusal to acknowledge jurisdiction to the World Court in that case filed by Nicaragua. He stated that "*The World Court has no political jurisdiction in the U.S.*" and that "*the United States will formally cease to recognize the authority (jurisdiction) of the World Court except in non-political cases.*" Charges of "genocide" fall under the heading of "political jurisdiction." If Reagan is a man of his word, why doesn't he protect us from international political cases? But then, if he had in mind to protect us from international political prosecutions,

why was he in favor of ratifying the Genocide Treaty? And why would he allow Jews to extradite and prosecute old sick men who have lived many useful, peaceful years in America, and are guilty of nothing more than having been a loyal German soldier a long time ago in W.W. II?

God save America! God open the eyes of Americans!

JOE NEWMAN'S ENERGY MACHINE: It could revolutionize the world if it proves true, and so far, no one has been able to disprove it. Electrical experts, scientists, engineers, nuclear physicists, skeptics and critics by the thousands have examined Joe Newman's invention and agree that it does what he says it will do. His "energy machine" is an electric generator that produces more power than it takes in. If his theory of electricity is proven, many physics textbooks will need to be amended, or thrown out.

Newman claims to have discovered an energy source found in magnetic fields. According to his theory, he develops a controlled energy reaction similar to what happens in nuclear reactors. He claims that his machine uses an energy source which is virtually inexhaustible, and free. He has some working prototypes on display at his residence in Lucedale, Mississippi.

The fact that this source of energy is FREE is probably why neither the utility companies, nor the government are giving Joe Newman a hand in developing his invention. With FREE ENERGY there is no incentive for those who are in the business of exploiting and fleecing the flock. With FREE ENERGY, banks and governments would give up a large part of their control over the public.

He has been trying to get this machine on the market for several years, but has been stopped cold by the bureaucrats. Why has an invention like this been ignored and repressed for several years? The fact is, marketable models could already be in production all over the world, providing free energy for people who are freezing to death in winters, and others who are paying \$400 a month for electrical utilities to keep from freezing. But FREE energy isn't in the best interest of the utility companies, nor the banks. It would destroy their monopoly on energy resources.

Since banks and utility companies wield power over Congress, and apparently over the patent office too, Joe Newman is getting no help. He has applied for a

patent so he can produce his machine but the patent office refuses to give him one. They claim that his invention sounds too much like a "perpetual motion machine," which they've declared unpatentable. However, he has carefully explained that it is not a perpetual motion device, but that it simply uses a form of energy which is not currently used or recognized by the major utilities. So far his appeals to the courts and the legislature have failed to produce results. However, Joe claims that he will not give up until his machine is available to the public.

ENERGY MONOPOLY: Is there a conspiracy to suppress alternative energy sources and new inventions which could emancipate Americans from slavery to the energy companies? In the past few years, we've heard some startling things about energy resources.

First, Lindsey Williams, Chaplain on the trans-Alaska oil line, told about the oil companies being forced to cap their wells in Alaska, thus creating a fake oil shortage in America. In spite of enough readily-available oil to keep America afloat for hundreds of years, Americans were told that we were almost out of fuels. Thus, the price went sky high, and for a while it was hard to find your local service station open at the time you needed gas. Next comes Galen Winsor, from Richland, Washington. As a pioneer in nuclear engineering, he played a vital role the industry almost from its beginning. Now, he tells us that America has been tricked into an inordinate fear of nuclear radiation in order to shut down reactors. Thus the nuclear energy industry has likewise been stymied to prevent America from having a viable, less expensive option to existing utilities. Now comes Joe Newman's invention which is potentially the most simple, clean, and economical source of energy. On top of that, the potential benefit to science and mankind goes far beyond breaking the initial electrical utilities barrier. This scientific breakthrough would reshape the world even more than did the discovery of the atom.

These separate stories seem to have something in common; a pattern has been forming. They are evidence of a conspiracy to control energy resources. To maintain their power over the public these conspirators have successfully controlled and manipu-

lated both the oil and the nuclear industries. Perhaps the reason Joe Newman is being held back from getting his patent is to give "the powers that be" more time to figure out how to control and suppress his invention before it is allowed to go on the market. However, once the public has access to it, I doubt this machine will be easily suppressed.

The reason oil and nuclear energy have been easily controlled is because of the tremendous expense required to produce it. But, Newman's machine would probably cost less than the family car, and it would last a lifetime. Can you imagine what it would be like to have your own independent, inexhaustible power source?

MARXISTS IN MANILA: At the time of this writing, Philippine President Ferdinand Marcos' government has been overthrown by revolutionary followers of Marcos' rival Corazon Aquino who claimed that Marcos defrauded the Philippine people in the recent presidential election. Marcos won the election, but Aquino has now taken over through a semi-violent revolutionary coup.

Marcos has resigned and fled the country after President Reagan asked him to quit, calling him "an old friend and ally." The U.S. State Department had officially stopped backing Marcos and warned him against using force to suppress the revolutionaries. Reagan also promised Marcos a safe haven in America.

Washington has officially recognized Aquino's new government, while the revolutionaries in Manila are busy invading and destroying the former President's quarters and offices. The revolutionaries wear yellow ribbons (the symbol of Aquino's movement) and drape them over balconies. The presidential palace will now house the new lady President, "Cory" Aquino. Two of her daughters, Pinky and Balsy, were with her when she was sworn in as president.

If you have followed the events which led up to this, you probably have already recognized that it is a typical

Soviet conquest. The steps to this coup are the same that were used in Iran to overthrow the Shah and disrupt Iran just a few years ago. They are the same steps which could happen in America. In fact, these steps are already in motion right here under our noses.

The steps, briefly, are: 1. Set up a power-hungry, corruptible administration over the country. 2. Support him while he gains enough power to suppress the citizens, steals the wealth of the country and makes the people hate him. 3. Send in outside organizers to collect disgruntled citizens into potential riot mobs. 4. Then, expose the administration's excesses and abuses through the media, and raise a revolutionary army. 5. Next, remove the financial and political backing which had supported that administration in the beginning, leaving the nation helpless before the revolutionaries. With the citizens having been oppressed and persecuted by the abusive former administration, they are willing to accept any alternative government; even Communist.

After World War II, the new Philippine government was set up after the pattern of the United States. You might say it was a model of our own government. By the same token, this successful Marxist revolution is a model of what could happen in, and is undoubtedly slated for, America.

LIBERALS OR CONSERVATIVES? Have you ever noticed that some politicians, and some special interest groups, vacillate back and forth between liberal and conservative points of view? Which way they lean depends upon the issue. In fact, neither "liberal" nor "conservative" are adequate terms to categorize them because they are not consistently in either camp.

There is a term which is usable, and seems to apply. Politicians and special interest groups should be classified either "Christian" or "anti-Christian." It is useful to be able to categorize people in terms of "friends" or "foes." By categorizing in this manner, you can accurately predict which way they will lean. Certain types of people will strive to avoid Christian values and standards, but certain others will strive to keep them. One type is Christian, the other is anti-Christian. Any other means of classification will be generally inconsistent and unpredictable. No other term is capable of capturing the true essence of the conflict.

HYPOCRITES OR ANTI-CHRISTS? Inconsistency marks the ranks of the worldly minded. When a Black Militant stands up for a cause, even an un-American one, the anti-Christ's applaud. Thus, our nation has

now enshrined Martin Luther King Jr.: a man whose Communist connections have been recognized by some of the most credible critics in America. However, when a Militant Farmer stands up for a cause, especially if it is a Christian one, the anti-Christ's attack with fangs bared. Hypocrisy?

Anti-Christian Zionist Jews took possession of Arab land in Palestine, set up a government and militarily defended it against the surrounding Arab natives. This they have done, and continue to do while our Politicians and Preachers support them and call them friends. But when Christian South Africa defends her government against the surrounding, threatening natives, our Politicians and Preachers side with the natives and call South Africa an enemy. Hypocrisy?

[By the way, the South Africans execute criminals for capital crimes, have prayer in public schools, forbid abortion, forbid pornography, and have this statement in their Constitution:

"In humble submission to Almighty God, Who controls the destinies of peoples and nations, Who gathered our forebears together from many lands and gave them this their own, Who has guided them from generation to generation, Who has wondrously delivered them from the dangers that beset them, We declare that we are conscious of our responsibility towards God and man . . . To uphold Christian values and civilized norms, with recognition and protection of freedom of faith and worship."

Many politicians in Washington D.C. put up a facade of being "anti-Communist" but refuse to stop preferred low interest loans and other U.S. support to the Soviets. They mount campaigns to warn people of the danger of Soviet military attack, but refuse to stop giving the Soviets the money, information, and technology they need to build the machines with which to attack us. The fact is that if we hadn't given the Soviets the war technology, they would not be threatening us with it today. Hypocrisy?

In public schools, if a child catches measles he cannot attend class. However, a child with AIDS is encouraged to attend, and the other children are forced to attend the class, exposing themselves to the AIDS victim. Hypocrisy?

U.S. lawmakers have declared it a punishable crime to destroy a fetus in the egg of an eagle, but they have sanctioned and subsidized the wholesale destruction

of human fetuses. Hypocrisy?

Well, in the examples above and other similar situations, "hypocrisy" doesn't quite explain it. The only word that accurately describes it is ANTI-CHRISTIAN: hatred for Christ and Christian morals.

How does it affect us? As soldiers of Christ, we must understand our mission in the world just as Jesus understood his. We must "*Be not overcome of evil, but overcome evil with good*" (Rom. 12:21). God created Israel to be "*blessing to all nations*" (Gal. 3:8). So we must take up Jesus' burden, not allowing ourselves to be discouraged or stopped when the world acts naturally and hates us just as Jesus predicted.

JEWISH SWASTIKA? The B'nai B'rith Messenger, Feb. 9, 1973, published an article titled: "SWASTIKA MOSAIC DISCOVERED IN ANCIENT ISRAEL SYNAGOGUE" Today, the swastika is identified with German Nazis. However, here is proof that this same symbol is used in a Jewish synagogue.

The article says:

"It was found in a mosaic pavement dating to the early third century A.D..

Swastikas as part of decorative compositions in synagogues have been known before, but this is the first occurrence of such a prominent one in the Jewish context."

Students of the occult know that the symbolism contained in Hitler's swastika is the same as that contained in the Jewish hexagram (or "the star of David"). Both symbols are in common use in world religions such as Witchcraft, Free Masonry, Hinduism, Buddhism, etc., not to mention Naziism and Judaism. Both symbols are a depiction of "the perfect balance": the union of opposites.

Was Hitler's "Aryanism" based on the same principles as "Judaism?" My research has proven that it was. Both Aryanism and Judaism are occult. Both are based on the belief in pre-existence, inherent godliness of race (racial supremacy), Masonic Millennialism, and Messianism. bureaus to invade the privacy of your home and confiscate your children? There seems to be more than typical government ineptitude involved. This movement seems to have financial backing. The "child abuse growth industry" profits from the financial benefits of child confiscation.

Agencies have a vested interest in having your child confiscated so their representative can place the child in a foster home. These "services" are well supported. Also, new prospective parents may have already agreed to give a sizable "donation" to the agency who then arranges a legal adoption. That is tantamount to child marketing. On top of this profit, the agencies may also receive government funds.

Agents and employees of these agencies certainly have a vested interest in keeping the child confiscation business operating. Christian parents, on the other hand, have a vested interest in putting a stop to them and the politicians who sanction them.

CENTRAL BANK NOT FEDERAL AGENCY: The following news clipping is further proof that The Federal Reserve System is an independent corporation. It enjoys government backing, but does not answer to Congress.

WASHINGTON (UPI) — Federal Reserve Board Chairman Paul Volcker Wednesday warned that subjecting the central bank's budget to the new Gramm-Rudman budget law, as some have suggested, could jeopardize its independence.

The Federal Reserve System, which is an independent agency operating on a calendar rather than fiscal year, is not included in the federal budget, but its net earnings from its banking services are paid to the Treasury and reflected in federal budget receipts.

Volcker told the panel that while the Gramm-Rudman restrictions do not apply to the Federal Reserve, the board would voluntarily revise its administrative budget to conform with the budget cuts throughout the rest of the government.

But he said Federal Reserve banking services — clearing checks, providing wire transfers and other payment services — will continue to be priced in a market-competitive fashion.

Volcker warned against subjecting the Federal Reserve to the same annual budget projection and reporting requirements of other federal agencies.

MONEY: The following quotation explains how the FED creates the reserve credit from which it then authorizes its member banks to loan billions of credit dollars at usury. By using the fractional reserve system, the credit expands exponentially by each bank through which it passes.

When the United States needs a Billion Dollars the Treasurer advises the Federal Reserve Bank Corporation of such a need.

The Treasurer advises Bureau of Engraving to print one Billion Dollars worth of United States Bonds.

The Federal Reserve Bank advises Bureau of Engraving to print \$1 Billion Dollars in Federal Reserve Notes. The Federal Reserve Bank pays the cost of the ink and paper - approximately one Million Dollars.

This Banking Corporation (Fed. Res.) swaps its Federal Reserve Notes for United States Bonds. How would you like to make \$999 Million by the Stroke of a Pen?

In accordance with the 1935 Bank Act, the Federal Reserve Bank can deposit one Billion in United States Bonds with the Controller of Currency and secure \$1 Billion in currency. The interest on the United States Bonds is payable to the Federal Reserve Bankers.

The Federal Reserve Bankers have learned an even greater swindle. They can legally hoard the \$1 Billion currency in their vaults and issue Billions of "Check-Book" currency every time they make a loan or investment. It is said to be a 320 to 1 ratio by the time the money gets down to the citizens at the grassroots. All of which collects interest and compound interest.

Unless we immediately restore to the Congress their Constitutional Right to issue and regulate our money (Art. 1, Sec. 8, Par. 5),

this once great Constitutional Republic will have gone to the FED.

Integration is labeled a 'sham'

Rights pioneer James Meredith claims race is 'No. 1 problem'

DELAWARE, Ohio — At 51, James Meredith has taken an unexpected turn in his march into American history. The black man sparked white riots by integrating the University of Mississippi in 1962 and was shot for walking to protest segregation in 1966. Now he preaches that integration is a "sham."

In a day of lecturing here at Ohio Wesleyan University recently, Meredith said that the only people benefiting from integration are liberal whites who gained control of black votes for political fights, and a few "black bourgeoisie" who sold themselves to liberal whites as the voice of the larger black population.

Meredith also spoke with disdain of his former civil rights fights. He said there is "no history I've been a part of that's worth

writing about, nothing that has made black people more viable, competitive."

The only worthwhile accomplishment of the civil rights era that Meredith acknowledged is Title 2 of the Civil Rights Act of 1964, which grants blacks the right to stay at hotels and eat at restaurants.

Meredith told startled students and faculty that he thought American blacks are worse off than at any time in history, including slavery. He argued that integration has ruined black education by taking away from black parents the control of their children's education. He said integration has antagonized whites to the point that they do not want to hire blacks, and has left record-high black unemployment. Integration has destroyed the black family as black children are told white schools, white neighborhoods, and white stores are better, he said.

Meredith said whites are avoiding the "No. 1 problem in America, race," by staying away from blacks whenever possible.

"I'd rather be lynched than ignored and treated like I didn't exist," Meredith said. "It used to be whites would exploit blacks for cheap labor, even slave labor. Now you don't see blacks picking the fruit or cotton, or waiting tables. Whites don't even want to exploit black labor. I'd rather be exploited than ignored."

The hope for solutions is to be found in whites who are around the age of 30, Meredith said. They know how badly integration has failed because they have had firsthand experience with it in schools, he said.

They do not want their children to go through the class and racial strife of school life as they experienced it, he said.

JEW'S PRIVILEGED IN ROMANIA: This article appeared in the Arizona Republic, Feb. 8, 1986:

"As chief rabbi of an atheist country, Moshe Rosen would appear to be living the wildest dream of most clergy. Thousands of Romanian Christians, most of them Baptists, are flocking to Rosen to request that he convert them to Judaism."

Why are Romanian Christians anxious to become Jews when we've been told that Jews suffer dire persecution in Communist countries? The article continues:

"...they believe that becoming Jewish will enable them to emigrate from Romania. The communist government has allowed tens of thousands of Jews to leave for either the West or Israel."

In fact, from the article, one could surmise that the "Christians" in Romania have had to blend their beliefs in with Jewish beliefs in order to survive. They are quoted as telling Rabbi Rosen, at the time they come to him for conversion:

The article ends with:

"Nearly all the Jews in Romania are elderly and want to die in their native land."

Are these the words of people suffering persecution, or are they the words of contented citizens?

Yet, amazingly, the world perceives Jews as a people who are treated unfairly. Jews have the uncanny ability to convince the world that they are being persecuted everywhere and at all times. They manage to sell this story even though they, as a group, are the richest and most pampered people on earth. As a whole, they remind us of a spoiled, self-centered child. You've seen the kind; those who can think only of themselves. Their problems are always "the biggest and worst in the world." "No one has ever had such problems."

Of all the ethnic groups in America, the average Jewish family receives the highest income: 172

percent of the average in the nation. No wonder they are so big in banking and movies: they are the world's best at making money by spinning wild tales.

Chemist: Moses cured AIDS-like disease by killing carriers

LONDON — A British chemist working in New York City says that a disease similar to AIDS is mentioned in the Bible — and Moses contained it by killing all potential carriers.

"The book of Numbers in the Old Testament records that a plague struck the Israelites in the plains of Moab after they consorted with prostitutes," said John Gwilt, vice president of the New York-based Sterling Drug Inc.

"The disease does seem to have been virulent and sexually transmitted, although we can't prove it was AIDS unless we had the antibodies of that time, and I think it's too long ago."

He said the story of the plague and its eradication is contained in Numbers 25:1-9.

Gwilt, who is visiting London, said he has made a lifelong study of medical references in the Bible and found "striking parallels" to modern diseases.

In a lecture Tuesday night on "Biblical Ills and Remedies" to the Society of Apothecaries in London, Gwilt noted that Moses' remedy of widespread killing would be "unacceptable today."

AIDS SHOTS? One of the possible ramifications from the attempt to get a "cure" for AIDS is that a "shot" will be developed from which some pharmaceuticals laboratory will make a bundle of money. On top of that, millions of people may receive these shots when they don't really need them.

Remember the 1976 "Swine Flu" shots? It's possible that a similar thing is going to be repeated with "AIDS shots." If, and when, such a shot becomes available, you can bet that most people will run full speed to their nearest doctor to get it. God only knows what the results will be.

In '76, Gerald Ford spent \$135 million of government money to implement the Swine Flu Shot which then killed 32 people (these were the reported deaths; God only knows how many others died but were reported as some other cause), paralyzed 500 others, and subsequently cost another \$76 million in suits and settlements, and it is not over yet.

The fact is that doctors and scientists haven't the slightest idea of how to stop a virus anyway. No shot can kill a virus, and like the flu, AIDS is a virus. An honest doctor once told me that the only things that can stop a virus is heat, and a person's own immune system. If that is true, then the best way to avoid or combat viral infection is to keep your body's immune system healthy. That, apparently, is what most AIDS victims do not do. Constant abuse and insult from drug needles and bizarre sexual practices tear down and eventually destroy their immune systems. Once a person loses his immune system, there are a million diseases waiting to infect his body, any one of which will kill him.

Dr. Schuller wants to build bridges between the U.S. and the Soviet Union. In his letter he says, ". . . it

would be important for us to recognize the strong, steady, solid influence of a person I am privileged to know as a friend: Dr. Armand Hammer."

Schuller closes the letter by stating that "Ronald Reagan and Armand Hammer are peace makers, bridge builders, doers, and possibility thinkers of the highest order. As a citizen of the world, as a child of God, I thank them both." He signs, "The Rev. Dr. Robert H. Schuller, Garden Grove, CA."

Armand Hammer is well known for his international financial ties with Communists. Schuller tells of his closeness with Hammer; Hammer's closeness with Soviet leaders, including Gorbachev; and Hammer's role in arranging the summit meeting between Gorbachev and Reagan. Boy, all that closeness kind of makes me sick!

Anyway, I'm glad that I am a citizen of The United States of America, and not "a citizen of the world," and that Armand Hammer doesn't have to share with me the distinction of being called "a friend of The Rev. Dr. Robert H. Schuller!"
