AMERICA BETRAYED BY NEW MEXICO GOVERNOR

Governor Toney Anaya, on March 29, declared New Mexico a "state of sanctuary" for fugitives from Mexico and Central America. The influx of illegal aliens was already alarming. Now, that flow across the border will increase.

The declaration does not forcibly stop the border patrol from catching and returning the fugitives, but it

does urge New Mexico citizens to not cooperate with the authorities and when possible to try to thwart their efforts in arresting and deporting the illegals back to their own lands. The declaration itself does not make any laws. It does, however, mold public sentiment, encouraging the illegal aliens to enter New Mexico and eventually other states.

Anaya's action is a breach of his oath of office and betrayal of his position of public trust. His purpose is to look after the welfare of the citizens of New Mexico and the United States, not fugitives from Central America and Mexico. However, the outcome of this move may be beneficial in the long run. Not only has it exposed


the governor's un-American loyalties, but it will possibly open the eyes of the citizens along the border that their biggest problems are in their own government, not on the border.

NATIONALISM: National borders and national laws precipitate independence. Internationalists hate nationalism. Communism, therefore, is antinationalist. The following article from the September 1982 issue of "The Observer" shows how Communists must constantly suppress nationalism, even in Russia:


A senior official in the Soviet publishing world has been arrested after coming under

suspicion of being involved in a clandestine youth group espousing extreme Russian nationalist and antisemitic views.

The official, Dr. Sergei Semanov, was both a chief editor of the Soviet Communist youth organization's publishing house "Youth Guard," and editor-in-chief of the journal "Man and Law," which is published

the Soviet Justice Ministry.

Semanov's arrest represents the most important move by Soviet authorities against unpalatable forms of Russian nationalism since the imprisonment of the Slavophil dissenter, Vladmir Osipov, in 1974.



Russian nationalists stress the spiritual supremacy of Russian culture - as opposed to Soviet culture - and often embrace the Russian Orthodox church. They are often virulently antisemitic.

It's no surprise that the Soviet government is antinationalist. It is the nature of that beast. However, we see definite forms of the same thing being practiced right here in America, in Washington D.C.. One of the most recent evidences of this was their ratification of the international Genocide Treaty: an anti-nationalist, anti-independence compact with several other nations. Why are the tendencies and goals of the U.S. government paralleling those of the Soviets?

The Genocide Treaty was, without question, the product of anti-nationalist thinking. The appeal was a spinoff of the well-worn "Jewish Holocaust" propaganda also labeled "genocide." Raphael Lemkin, a Polish Jew, coined the word "genocide."

That the Genocide Treaty came from Talmudic mentality is indicated further by its close resemblance to the recent bill introduced into the Israeli Knesset (legislature) to outlaw so-called "racism." It is obviously intended to censor <u>Palestinians</u> who might speak out against the Zionists. This parallels the measures being instituted in Canada and America to censor <u>Christians</u>.

Here are some of the points contained in the Israeli bill:

- 1. "Racism" is defined as any act causing persecution, hatred or humiliation directed against a racial or religious group.
- 2. Anyone who publishes any incitement to "racism" whether it contains truth or not, can be sentenced to up to five years in prison.
- 3. Anyone who possesses a publication with intent to distribute it to incite "racism" can be sentenced to one year in prison and confiscation of the publication.
- 4. Any spoken words of "racism" which may be heard by persons, or the display of writings, drawings, pictures intended to be seen by persons can result in one year in prison.

What constitutes "racism" is always determined from the standpoint of those in control of a nation's legislature and courts. The Jewish rulers in Palestine obviously do not view anti-Arab prejudice as "racism." On the other hand, anti-Jewish prejudice is considered not only "racism," it is called the greatest evil on earth. Orwell coined the term "doublethink" for this strategy of using a double standard to control people's minds.

The pattern is typically communistic. Communist revolutionary movements climb to power by <u>demanding</u> "civil rights," and then once they are in power they stay there by <u>suppressing</u> those same "civil rights." Zionists have occupied Palestine the same way Communists have occupied Russia.

who is Lyndon Larouche? Lyndon Larouche, the pariah of the current U.S. political scene, is the head of the National Democratic Policy Committee, an organization apparently set up by Larouche himself. He publishes "New Solidarity," a bi-monthly newspaper with a large intelligence-gathering network. He also publishes numerous other writings dealing with political issues and economics. He ran for president three times and plans to run again in 1988.

Research indicates that LaRouche was a Communist (Trotskyite) before he switched to be a Democrat. His political and economic views tend toward internationalism. However, he has carefully chosen some

of the right foes to make him look as if he were a conservative patriot. He is not! He is a radical liberal.

Some of the ostensible foes he has named are Henry Kissinger, international bankers, the FED, and AIDS. At first glance, LaRouche is an enigma, saying some of the right things but seasoning them with other things that don't make sense. However, upon further investigation it becomes apparent that his inconsistencies only disguise his true motives. We only see his public image, not his real self.

By carefully reading his publications one can see that he is not against the idea of central banks or international cartels, he only wants them reformed to his way. He is not for free trade, he is for usury and capitalism. His writings portray him as a Humanist, not a Christian. His brand of politics seems to be a type of national socialism. He certainly is not a "great white hope" for America. By the same token, he is probably no worse than many of the other politicians already in government.


Several members of his committee are running for state and national government around the country on the Democratic ticket. Recently, in Illinois, Mark Fairchild and Janice Hart, two of his people, won positions in the primaries on the party ticket. Fairchild won the nomination for lieutenant governor, and Hart won the nomination for secretary of state. The resulting shake up has caused tremors that were felt in political circles all across the country. All of a sudden, the media and the politicians are taking LaRouche seriously.

Mark Fairchild's nominated running mate for governor, Adlai Stevenson, doesn't want to share the ticket with "one of LaRouche's disciples." He has renounced his Democratic nomination rather than run on the same ticket with Fairchild. Stevenson will apparently try to run on an independent ticket with a different lieutenant governor running with him. If nothing else worthwhile comes from this perhaps it will at least neutralize Stevenson.

STATE KIDNAPPERS: The scene is nasty and heart-rending. State or local officials can force their way into your house and take your children. You need to be aware and prepared!

I have talked to homeschoolers and other parents who suspect that their home may be unlawfully violated by State or local officials trying to confiscate (steal) their children. They have learned how to keep careful watch for any signs of such an invasion. Often, direct confrontations have been avoided and thus parents have kept their children out of the hands of abusive "agencies." They've done this by staying alert and getting their children out of the house at the first sign of possible trouble, preferably long before the agents pull into their driveway. These parents are arranging for their children to be quickly taken to a nearby home of a trusted friend or relative. Of course, these arrangements are kept strictly confidential.

The State does not have the authority to steal children, but unfortunately it does have the power. Parents have the God-given responsibility to look after their children and protect them. What would you do if a county worker with a local deputy showed up at your door with orders to arrest you and take your children? It's something to think about.



LAW OF THE LAND: American patriots are often heard talking about "the supreme law of the land." Most will tell you it is the Constitution. In fact I think I've said it myself in the past. In a recent lecture by R.J. Rushdoony, I was reminded of the inaccuracy of that statement. We must be careful not to confuse this important fact.

The Constitution is the highest MAN-MADE law in America. However, in a Christian society, man's laws are not supreme! There are higher laws! In a Christian society, the Constitution is merely a covenant between men - UNDER the laws of God.

God's law, His word, is the supreme law of this land. This is proven by the law of creation. A creator is always superior to his creation. Man created the Constitution, but God created man. Therefore, where men are, there is of necessity also the higher laws of their Creator.

In our Pledge of Allegiance, the phrase "under God" clearly places God and his law over all our man-made

authorities.

Another witness to the above premise is the well-known fact that everyone who serves under the Constitution must take an oath of office. The oath of office places that officer under God's authority. The oath is sworn to God. If the Constitution were supreme, instead of God, then the oath would be sworn to the Constitution. But it is not. It is sworn to God. For an oath to be binding, it must be sworn to a higher power. The Constitution is not higher than man who created it.

Bouvier's Law Dictionary defines "oath" as:

An outward pledge given by the person taking it that his attestation or promise is made under an immediate sense of his responsibility to God.

The essential idea of an oath would seem to be, however, that of a recognition of God's authority by the party taking it, and an undertaking to accomplish the transaction to which it refers as required by his (God's) laws.

The oath is often taken with one hand upon the Christian Bible. In other words, the oath requires a man to perform the duties of his constitutional office under God's authority and according to God's rules of conduct and morality. Without God's law the Constitution has no basis for existence, nor enforcement.

The Bible tells us that the land belongs to God (Lev. 25:23), and that we belong to God (I Cor. 6: 19-20). Until the day when people are sworn into office by taking an oath to a document, or to men, we and our manmade laws are still under God who alone is sovereign.

THE STEALTH OF COMMUNISM by Virginia Thurman

In 1959, while attending the University of Wisconsin, I went to Russia with a group of fellow students. We were told this was the second year that Russia had opened its country to tourists, and that we were lucky to be invited. Furthermore, we were warned that for no reason other than "suspicion" of tourists, certain individuals may not be allowed to enter Russia and would be turned back at the border of Finland and Russia. In the group of 25 immediately ahead of us, only 6 were allowed into the country. This filled us with

trepidation since we had come so far already and possibly some of us would have to go back without seeing Russia.

Had we thought about it, we would have realized that anyone from the University of Wisconsin would have been without suspicion as far as the USSR is concerned. In fact, Milwaukee, Wisconsin boasted a "training school" for Communists only one and one-half hours away from Madison where the University is located. I don't know if the school exists today, but at that time the U of W was a hot-bed of Communists. When our group got to the border, all 29 of us walked across without trouble.

Inside Russia, we were amazed and then annoyed at the posters and slogans, large and small. They were plastered on the buildings everywhere. Some posters had letters large enough to be read from the bus if you knew the language. We saw innumerable statues of Lenin "pointing the way."

Our unfamiliarity with the language precluded most of us from reading the posters. When we went to the University at Kiev, once again the hall was full of messages. One of our guides from the U of W, Dr, Petrovitch, was the son of an Orthodox Priest and spoke Russian like a native. I asked him, pointing at random to one of the posters, to tell me what it said. He read, "HOW TO AGITATE," and it gave the points step by step. Then I pointed to another sign across the hall. He read, "THE DARK CONTINENT MUST BE OURS. WE MUST WIN AFRICA." The rest of the poster gave the details.

That was in 1959. Since then, most of Africa has become Communistic through "the people's revolution." What we see unfolding before our eyes in South Africa is not coincidence, but the well-planned and directed take-over of a nation.

In the last 68 years we have witnessed world revolution via Communism, backed by billions of U.S. dollars the taxpayers have given almost unknowingly. Without question, much of this money has gone to supply war material which is used against those countries who are fighting for freedom. If Russia's plans are successful, those same guns and war equipment may be turned against us via Central America.

Shortly after returning home, I found a booklet in my mailbox, type written, and copied from the original. Whoever left this booklet was sure I was a Communist. The booklet gave instruction to the reader on how to behave as a Communist. For instance, it said "Join every group you can, then ask disruptive questions.

Cause dissent whenever possible. Do anything to keep them off balance. Interfere enough so the mission of the organization cannot be realized, but not enough to cast suspicion upon yourself. don't hesitate to tell a lie, because lying for our cause is really telling the truth."

Further on I read, "If you are a teacher, preacher, doctor or have influence in these fields, do what you can to get people to go to psychiatrists to solve their problems. Make people feel the psychiatrist is the only person qualified to hear their complaints. Make going to the psychiatrist as common as going to the dentist. We know the psychiatrist can control the minds of people, and we will control the psychiatrist." A great deal of the booklet was devoted to "Mental Control," and "what we as Communists can do to make the people think psychiatry is the answer."

In these few ensuing years, this idea has been expanded to include our schools where children are indoctrinated and forced to tell what transpires at home, or make confession of every facet of their young lives. It all started at the turn of the century. We have been slowly mesmerized into thinking it's OK.

Because my husband was in the Military Service at the time, he insisted we call the FBI that day and explain how we came to have possession of the booklet. We gave them the book. When I remember those Communist instructions, I wish somehow the book could have been saved, if for no other reason than to see how far we have come along their road. Up until the present, a shot hasn't been fired, but the noose around our necks has tightened perceptibly.

IRS NEEDS MONEY: An Associated Press article of April 3, reports that Roscoe L. Egger Jr., said that the Internal Revenue Service will face disaster unless Congress approves an additional \$340 million in operating funds. "If we don't get any part of that, we would have to begin furloughing people, we would have to cut back immediately on returns processing, the refund time period would stretch out dramatically and so on," Egger told reporters. "That \$340 million is a must.... We'd be out of business sometime in August or thereabouts." Egger said he plans to retire from the IRS by the end of April.

Will Congress give the IRS the additional money they need to stay afloat? Probably. But, isn't it interesting that the IRS is speculating that they could be "out of business" within half a year? If any of you find an update on this situation, send me a copy of the article.

NUT OF THE MONTH: Kay Fishburn of New Berlin, Wisconsin is donating her nickels and dimes to the Bureau of Public Debt to pay off the national debt. She is National Coordinator of Citizens for a Debt-Free America, and is calling on all Americans to make tax-deductible donations and "take responsibility for their share of the deficit." Bureau spokesman Ron Couch says, "Some people send us their Social Security checks. Some people in nursing homes send us \$1 a month."

Let's hope that these people are not too prevalent among us. With a few thousand people like that in the Colonies, they would have figured out how to "donate" to England the tax she lost in the Boston Tea Party.

GOOD MONEY: The Argentine provinces of Salta and La Rioja are printing their own money. People can use it to shop at supermarkets, buy cars, exchange for Argentine money or for any other purpose according to the Governor of Salta, Roberto Romero. Bypassing banks and printing money directly breaks the grip of international banks. The International Monetary Fund is so concerned that it brought up the issue in recent talks with the Argentine government. (Portfolios Investment Advisor, April, 1986)

NUCLEAR ACCIDENT IN RUSSIA: What really happened? Did thousands already die from the "deadly radioactivity?" Will a "radioactive cloud" kill thousands more in Europe and America? Boy, what a heyday for the newsmedia! They've successfully incited panic as far away from Chernobyl as California. The nuclear scare hype has been effectively multiplied by the newsmedia's handling of this incident.

The explosion at the Chernobyl plant was caused by pushing forty-year-old technology beyond its limit. The reactor was outdated and inefficient by today's standards. They were trying to extract more energy than it was able to safely produce. The reactor was an old model using graphite as a moderator instead of a liquid solution. When the demand for energy became greater than the old reactor could produce, instead of re-designing the core they just over-enriched their uranium reactor rods in an attempt to make them produce more heat.

This eventually resulted in too much heat in the core, causing the graphite to overheat and blow up. It was not a nuclear explosion. The nuclear reaction had been shut down before the explosion occurred. The rods had already been "poisoned" (inactivated). The explosion was a chemical reaction, not a nuclear reaction. Graphite is a chemical that will explode and burn. The resulting fire was a chemical fire, not a "nuclear fire" as the newsmedia would have us believe. The core was surrounded by several tons of graphite. That large chunk of graphite sat there and burned, on its own, for several hours. Graphite, like charcoal, will burn

without flame. It was finally extinguished by helicopters dropping sand on it.

How many people died? Western media estimated two thousand. Russia said just two. Now, the media is admitting that the Russian figure could be correct. What was the cause of death for those two? Did they die from nuclear radiation, or from the concussion of the exploding graphite? The answer is obvious.

What then, hasn't anyone died from radiation in this terrible "nuclear accident?" Not even one? Well, if you can find one let me know.

People think that thousands are dead and dying because of the deadly radiation. "No one is safe from the radiation!" People in America "are berserk" for fear of radiation according to another article from Associated Press. In Sweden, and parts of Europe, people have been warned against drinking milk from cows that might have gotten "poisoned." The bottom has dropped out of the fresh vegetable market because people are afraid of getting poisoned from the radiation that leaked into the atmosphere hundreds of miles away at Chernobyl. Panic and fear are running rampant.

A UPI report from Bonn, West Germany declares: "Radiation (from Chernobyl) 1,000 times higher than at Hiroshima." But what it doesn't mention is that at Hiroshima the radiation was all produced in a split second. At Chernobyl, it is being slowly produced over a period of several days. That makes a tremendous difference. A wood stove can radiate millions of BTU's over a period of time, safely heating your house. However, try to make it produce all that heat within a time period of one second and your house will burn down.

It's too bad all these brainwashed people haven't seen our video, THE NUCLEAR SCARE SCAM, by Galen Winsor. On this tape, veteran nuclear physicist Galen Winsor eats uranium oxide: the actual material nuclear fuel rods are made of. SILVER FUTURES: If you have been holding silver, hoping that the price will go up like many of the misinformed patriots have been predicting, it looks like you've been left holding the bag. Indications are that silver will continue its current downtrend for some time. One reason is that there is a great deal of silver being produced right now. For instance, in 1982, the Lucky Friday Mine in Kellogg, Idaho discovered a vein of silver 3,500 feet underground, that yields 9,000 ounces of silver per ton of ore. With such a rich yield the Lucky Friday Mine caused the silver market to drop, hurting and eventually closing some other mines that couldn't compete. It is still operating and has the vein mapped and planned with proven reserves for five years ahead. I don't look for silver to increase in price for a long time, and when it does there are still many mines waiting to go back into production.

SHOULD LAWYERS MAKE MERCHANDISE OF MISFORTUNE? According to "American Manners and Morale", by Mary Cable, Massachusetts in 1641 adopted a law making it illegal to earn money by representing another person in court.

In the same vein, Virginia legislators in 1658 actually passed a law expelling all attorneys from the colony. It was not until 1680 that the law was repealed and lawyers were allowed to return.

Perhaps the American Bar Association should be grateful that history is silent as to whether colonial life improved while the lawyers were gone. (Phx. Gazette, 7/30/83)

CONTEMPT OF COURT IS LYNCHING: When the courts want a man bad enough, they seem to get him one way or another these days. As a last resort, when they cannot make the charges stick, and when they cannot force a confession out of the defendant (under the 5th amendment a man cannot be forced to testify against himself), the judge will often hold him in

"contempt of court." Thus, the defendant goes to jail, not for a crime, not because of the decision of a jury, but for "contempt." Thus, he must stay in jail until he repents and agrees to cooperate in his own prosecution. Many patriots and pastors are in jail right now on this charge.

As the following article explains, a judge does not have the rightful authority to punish a person for "contempt."

No person can be deprived of their life, liberty or property, or be fined or sentenced to prison unless convicted of a crime by a jury.

In "Contempt of Court," there is no arrest, no bail, no rights read to the victim, no due process of law, no conviction by a jury (as the U.S. Constitution requires) and no trial. It is lynching.

Also, the victim in "contempt of court" is convicted by a judge. Judges do not have the power to convict anyone of a crime or find anyone innocent of a crime.

In "Contempt of Court," lawyer-judges do the accusing, the prosecuting, the convicting and the sentencing, all without a trial. It is nothing but lynching.

After experiencing the tyranny of the judges with despotic powers under King George (read the Declaration of Independence), the people refused to give any judge or any other government official the power to convict any of the people of a crime or find anyone innocent of a crime. The people (the jury) kept this power for themselves, so that only the people (the jury) could decide the guilt or innocence of any of the people.

Article III. Section 2 of the U.S. Constitution states: "The trial of all crimes, except in cases of Impeachment, shall be by jury." Only the people (the jury) can convict anyone of a crime or find anyone innocent of a crime. No judge or any other government official has this power. The U.S. Constitution forbids it.

In this Republic, nothing (under God) is above the people; not even the courts. The 7th Amendment re-affirms this when it states that "no facts, tried by a jury, shall be otherwise re-examined in any court of the United States." Otherwise, the courts would be above the people and our government would be governed by a ruling class, creating an aristocracy which is forbidden by the U.S. Constitution. A jury's verdict cannot be appealed.

Since the trial of all crimes, except in the cases of impeachment, shall be by jury, no individual can "waive" this "right" as that would not be "waiving" a "right," but actually amending the U.S. Constitution.

The lawyers and lawyer-judges disobey the U.S. Constitution. It is a felony not to expose crimes, and lawyers are worse than murderers. Organize your family, friends, neighbors and demand the local people to outlaw the lawyer profession. Only by outlawing the lawyer profession can the people re-establish the Constitution and regain the rights of The People, free elections, free speech, free juries, and public safety.
