No Known Vaccine Available To Halt the Deadly Menace

World Is on Brink Of Killer Flu Epidemic!

After a mild spread of the disease during the spring and summer months, the 1918 influenza hit humanity in the fall and winter like a giant, unseen scythe.

ONE BILLION people fell ill — one of every three persons in the world. Although government authorities worldwide played down the statistics, it was well known in medical circles that the epidemic ranked with the Black Plague of the Middle Ages as the worst disease disaster ever to hit mankind.

Death and suffering in the U.S. was immense, but compared to other nations, America got off rather easily.

In India, for instance, 12,500,000 people succumbed — one out of every 12. In the U.S., the death rate was one of 140.

In Europe, soldiers who had survived the murderous bloodbath of trench warfare for four years died by the thousands in military hospitals ill-equipped for the epidemic.

Most flu epidemics start early in winter and subside by spring. But killer epidemics are not so predictable. They can break out any time of year.

THE DEADLIEST epidemics hit much harder at young adults than normal outbreaks, which generally take their biggest toll among infants and old people. In 1918, the rate of flu among people aged 20 to 40 was twice as high as in other groups.

"If the swine flu should hit hard at this age group — which is the largest age group in the U.S. — the result could be more than 300,000 dead, and that's a conservative estimate," said a spokesman for the Federal Center for Disease Control in Atlanta, Ga.

Although there is no vaccine yet ready for swine flu, other medical advances since 1918 could cut the death toll.

Existing flu vaccines might work in isolated cases. Antibiotics might be of even more value.

ANTIBIOTICS neither prevent nor cure influenza, but they do help the body ward off secondary infections that result in a weaker physical condition allowing swine flu to strike harder.

"It is a dangerous waiting game," said the health spokesman. "You never can be sure about influenza. New viral strains are discovered all the time."

"We can only hope that swine flu does not take hold. If it does, then we must hope that medical science can quickly find a way to combat it."

Dear Ann Landers:

Facts On Swine Flu Shots Told

Dear Ann Landers: Please tell me (and millions of others) what this swine flu thing is all about. I need some no-nonsense answers to the following questions:

Why is the U.S. government spending \$135 million on a project when there is no evidence that there will be a swine flu epidemic?

When will the shots be available to the public?

Is there a chance that a person can get swine flu from the shot?

Who should take the shot? Who should NOT take it?

Is the shot safe for pregnant women?

How effective will the shot be?

What are the possible side effects?

Where will the swine flu shots be given?

How much will they cost?

Are YOU going to have a swine flu shot?

Thanks for your help. It's wonderful to have somebody to turn to for reliable information. — We Appreciate You In New York

Dear N.Y.: The U.S. government is spending \$135 million on the swine flu project because it believes in preventive medicine. There may be no epidemic but it one should occur it could be devastating. In 1957-58, over 70,000 people in the U.S. died of the Asian flu. In 1968-69 the Hong Kong flu claimed 30,000 lives.

The swine flu shots will be available by Oct. 1. Assistant HEW Secretary Dr. Theodore Cooper estimates that the shots should protect about 85 per cent of those who take them. (The other 15 per cent should get milder cases than if they had no shot at all.)

There is NO change that a person will get the flu from the shot because the vaccine is made of a killed virus. The only significant side effects MAY be a sore arm and a fever. (The government ran an experiment on 6,000 volunteers. Out of those who received the swine vaccine, 1.9 per cent developed a fever that lasted about 24 hours or less.)

Should children get the shot? The researchers are still working on dosages for children under 18. However, those children who are inclined to get fevers should NOT get the shot.

It is strongly recommended that adults over 18 get the regular swine flu shots (200 units of A-New Jersey/76). For the high-risk population (those over 60, those who have chronic heart disease, respiratory problems, diabetes — or cancer patients who are in treatment), a combination of the swine flu vaccine and A-Victoria/75 is recommended.

There is no reason why a pregnant woman should not take the swine flu shot.

It has been emphasized that the shot should NOT be taken by individuals who are allergic to eggs (this includes pregnant women).

The shots may be obtained from your physician, who may charge for an office visit but NOT for the vaccine. (He gets it free.) After Oct. 1, phone your local health department and ask where and when the shots will be offered in your city. They will be free.

Am I taking the swine flu shot? You bet I am. I'll be one of the first in line the moment they are available.

A flu virus that normally affects only hogs may wipe out millions of people beginning next year. Scientists worldwide are rushing to find a vaccine to halt the possible outbreak. So far they are unsuccessful.

The virus is very much like the one that caused a worldwide flu epidemic in 1918. Twenty million people died, 600,000 of them in the U.S.

It is not the same virus that has caused more than 1,000 deaths in the U.S. during the past few months.

The new virus, discovered in February at Fort Dix, N.J., is called swine virus because it usually strikes only hogs.

U.S. public health authorities have alerted the World Health Organization to the danger. That group has ordered its laboratories all over the world to be on the lookout for the virus.

THE HUNT for a vaccine has top priority. If an outbreak comes, it probably will strike late in 1976. There are only a few months left to find a vaccine that may save millions from agonizing death.

Drug manufacturers already were at work on two types of flu vaccine when word came from the government about the swine virus. The vaccines were effective against the Hong Kong-type flu, but not the new strain.

The sudden appearance of the swine virus has caused a drastic switching of priorities. Health officials now must decide whether to pour all available money and research into finding a cure and preventive for the swine virus-caused flu.

The wrong guess can mean death for millions. And there are only a few short weeks left to decide, because it takes many months to make enough vaccine to ward off an epidemic.

IF THE swine virus is as deadly as some scientists believe it to be, it already may be too late to prevent an epidemic — even if a vaccine is found tomorrow.

The 1918 epidemic struck just as World War I was coming to a close. Many victims in Europe died because their bodies already were weakened by the deprivations of war.

Already, historians are noting the beginning of parallels between the 1918 epidemic and the current situation.

In 1918, the killer of the disease was preceded by a milder epidemic such as the U.S. is experiencing now.

Swine Flu Immunizations Begin

Vaccine's Availability Will Be Limited at First

The long-delayed swine flu immunization program finally got under way Friday—but only for a limited number of persons.

Dr. Sheridan Weinstein, the top Public Health Service physician in the Pacific area, and a group of high-risk patients at the Wadsworth Veterans Administration Hospital in Los Angeles were the first persons in the West to get the

Kids' flu shots in short supply

CHEYENNE, Wyo. (AP) — A state health official on Friday said only enough vaccine to inoculate less than 7,000 children under 18 years of age against swine flu will be allocated the state.

Dr. H.S. Parish, director of disease prevention with the State Division of Health and Medical Services, said the 13,600 doses of vaccine will inoculate about 7 per cent of the 123,000 children under 18

against swine flu.

Two doses of the monovalent vaccine are required to protect the children against the swine flu, Parish said, meaning only 6,800 children will be able to receive the shots.

The health official said the vaccine will be distributed to private physicians based on community needs. He said the doctors will dispense the vaccine as they see fit.

He said the U.S. Center for

Disease Control limited the vaccine earmarked for Wyoming to 13,600 doses because no additional vaccine is being manufactured.

Parish said another 4,000 doses of bivalent vaccine, which guards against both swine flu and A-Victoria influenza, also will be distributed among the state's physicians. He said 2,000 children plagued by chronic diseases each will get two doses of that vaccine.

The state health official also said the Center for Disease Control has advised that young men and women between the ages of 18 and 24 receive a second swine flu shot to provide maximum protection.

Parish said one clinic will be held in each of Wyoming's 23 counties to inoculate persons within that age group and persons who might have missed earlier clinics.

THEY LIED TO THE PEOPLE

Dr. J. Anthony Morris, 25 years of experience testing long-range effects of vaccines for the U.S. Bureau of Biologics: "The people who initiated the program used a man-made virus to produce the vaccine. We don't know ANYTHING about it--yet they indiscriminately began pumping this POTENTIAL VIROLOGICAL NIGHTMARE into the arms of 40 million innocent Americans. We're already seeing examples of what tragic things can happen as a result. Even worse, we can predict that more and more tragedies linked to this vaccine are waiting in the wings." (Dr. Morris was fired by the H.E.W. in July of 1976 after he issued a public warning that the vaccine was unsafe!)

Dr. Ernest C. Herrmann, Jr., professor of microbiology at the University of Illinois: "We have a vaccine which NO

ONE CAN BACK UP AS SAFE." Dr. Herrmann, speaking of the U.S. officials in H.E.W.: "They've lied from the beginning because they said it's effective and they have no evidence of that. None of these people (in the tests) were ever infected by influenza virus--so they never proved effectiveness."

Dr. Hubert Ratner, a Chicago area health official for 25 years: "The vaccine isn't any good...The CDC knows it, and we know it."

Dr. Cyril Wecht, chief medical examiner, Allegheny County, Pa., who performed autopsies on 3 victims: "The government is doing everything possible to make sure there are some cases labeled swine flu to justify their massive immunization program and the catastrophe associated with it...People should have been advised to ask their doctor if the shots were safe for them, especially if they'd had heart attacks or high blood pressure--but this was not done."

Dr. Charles Stuart-Harris, a virologist at the University of Sheffield, England, Medical School with long experience with flu vaccines: "The only persons it [the dose given in America] could even possibly protect are those who've already been exposed to swine flu and have built up partial immunity to the disease." In other words--the vaccine couldn't protect 99% of those who got it!

Dr. Arthur Chanin, veteran Los Angeles Pediatrician, "The American Academy of Pediatrics has never recommended immunizing children routinely. The cumulative effects of repeated flu injections is not known and may not be known for decades." After more warning of the danger of the flu vaccine, he further stated what many other

doctors have admitted, "As we in the medical practice know, the flu is NOT a killer." (Yet the U.S. officials continually released warnings that tens and perhaps hundreds of thousands could die from the swine flu--it was a deliberate lie!)

Dr. Archie Kalokerinos, Australian physician who wrote a book on how mass immunization programs in Australia killed one-half of the Aborigine babies: "Immunization can cause sudden death. They say the serum [the swine vaccine] has been tested. I say that is bunk and my beliefs are backed by companies making the drug who refuse to sell it unless the government insulates them against death and damage claims." Dr. Kalokerinos further stated that every undernourished or ill person would be especially susceptible to injury or death from the vaccine, and said inoculating individuals without a prior physical examination made the program "a plan for mass murder." (As readers know, it was exactly the old and the ill who were urged to get the shots by government and news media!)

GOD ALMIGHTY WARNED US OF THE WICKED

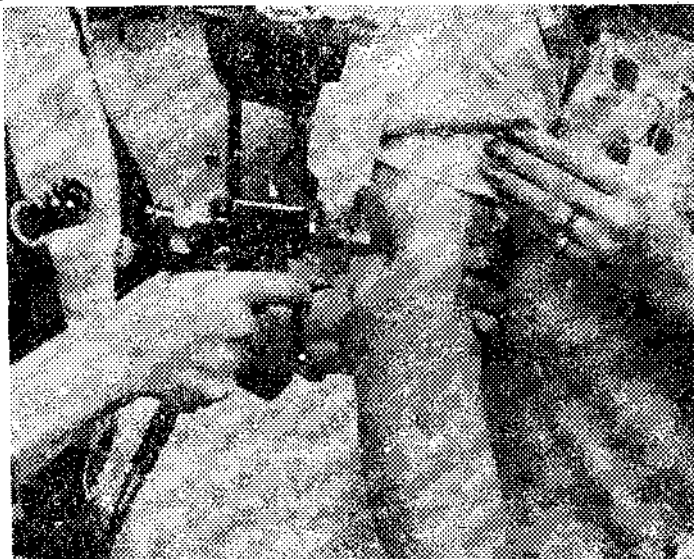
